## (forming part of the Foynes to Limerick Road (including Adare Bypass))

An Bord Pleanala ("the Board") has on the 30th day of August 2022 approved, with modifications, the above scheme under section 49(3) of the Roads Act 1993 (as amended) in respect of Limerick City and County Council, which under section 52(1) of the Roads Act 1993 (as amended) is authorised to compulsorily acquire any land or substratum of land or any rights in relation to land specified in the approved scheme.

A copy of the scheme as approved may be inspected for a period of 8 weeks commencing on 5th October 2022 (being the date upon which notice of the decision made of An Bord Pleanála to approve the above scheme with modifications was published) at the following locations.
