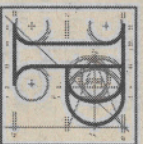
Fógra ón mBord Pleanála maidir le ceadú Scéim Bhóthar Cosanta Flaing go Ráth Caola 2019, Scéim Mhótarbhealaigh Rath Caola go háit Tí Flainn 2019 agus Scéim Limistéar Seirbhíse Flainge 2019 (lena bhfoirmítear Bóthar Flaing go Luimneach (lena n-áirítear Seachbhóthar Áth Dara)) (cás-uimhir thagartha ABP-306199-19) de réir alt 49 d'Acht na mBóithre, 1993, arna leasú.

Ar an 30ú lá Lúnasa 2022, i bhfeidhmiú na gcumhachtaí a thugtar dó faoi alt 49 d'Acht na mBóithre 1993 (leasaithe), rinne an Bord Pleanála ordú lenár ceadaloidh le mionathruite Scéim Bhóthar Cosanta Flaing go Ráth Caola 2019, Scéim Mhótarbhealaigh Ráth Caola go háit Tí Flainn 2019 agus Scéim Limistéar Seirbhíse Flainge 2019 (trína ndéantar Bóthar Flaing go Luimneach (lena n-áirítear Seachbhóthar Áth Dara) mar a chuir Comhairle Cathrach agus Contae Luimnigh faoina bhráid chun críocha an ailt réamhráite. Bainneam na mionathruite le sceidil athbhreithnithe agus léarscáilleana fosuithe gaolmhara a chuir an tUdarás Bóithre faoi bhráid an Bhoird Pleanála ag an éisteacht ó bhéal an 23ú lá Feabhra, agus achtoimítear iad mar seo a leanas:

1. Déanfar na Scéimleana a mhodhnú de réir na sceidil athbhreithnithe agus na léarscáilleana taiscthe gaolmhara a chuir an t-Udarás Bóithre faoi bhráid an Bhoird Pleanála ag an éisteacht ó bhéal an 23ú lá Feabhra 2021,
 - (i) Uasghrádófar Sceideal 1 (Cuid 1), Sceideal 1 (Cuid 2) agus Sceideal 4 de 'Scéim Bhóthar Cosanta Flaing go Ráth Caola 2019' chun léiriú a thabhairt ar leas Cragg Barrigone Group Water Scheme Limited.
 2. Ar Bhilleog 07 de 13 de na léarscáilleana fosaithe nuashonraithe, cuirfead mionathru i bhfeidhm (gearráid chloghráfaíoch a dheartú).
 3. Déanfar Scéim Mhótarbhealaigh Ráth Caola go háit Tí Flainn, 2019 a mhionathru trí phlota uimhir 435a.101 a fhágáil ar lár.

Notice of the approval by An Bord Pleanála of the Foynes to Rathkeale Protected Road Scheme 2019, Rathkeale to Attyflin Motorway Scheme 2019 and Foynes Service Area Scheme 2019 (forming the Foynes to Limerick Road (including Adare Bypass)) (case reference number ABP-306199-19) in accordance with section 49 of the Roads Act, 1993, as amended.

Further to the Board's notice published on the 12th and on the 14th September, 2022 you are advised that the URL was omitted from the notice in error. The URL is now specified as follows: <https://www.pleanala.ie/en-ie/case/306199>

An Bord Pleanála has, on the 30th day of August, 2022, in exercise of the powers vested in it by Section 49 of the Roads Act, 1993, as amended, made an order approving with modifications the Foynes to Rathkeale Protected Road Scheme 2019, Rathkeale to Attyflin Motorway Scheme 2019 and Foynes Service Area Scheme 2019 (forming the Foynes to Limerick Road (including Adare Bypass)) as submitted by Limerick City and County Council for the purposes of the said section. The modifications related to revised schedules and associated deposit maps submitted by the Road Authority to An Bord Pleanála at the oral hearing on the 23rd day of February, 2021, and are summarised as follows:

1. The Schemes shall be modified in accordance with the revised schedules and associated deposited maps submitted by the road authority to An Bord Pleanála at the oral hearing on the 23rd day of February 2021,
 - (i) Update Schedule 1 (Part 1), Schedule 1 (Part 2) and Schedule 4 of the 'Foynes to Rathkeale Protected Road Scheme 2019' to reflect the interest of the Cragg Barrigone Group Water Scheme Limited.
 2. On Sheet 07 of 13 of the updated deposit maps, apply a minor modification (correction of a typographical error).
 3. The Rathkeale to Attyflin Motorway Scheme, 2019 shall be modified by omitting plot number 435a.101.
